Book a CA by paying Rs 500

Before you schedule an appointment with a CA, may we kindly request you to deposit a small amount (Rs.500) towards booking charges. Assisted Filing Service is a premium service where our Tax Experts will ask for relevant information about your Income (including Financial Statements, if required) as well as other details, consult through a live chat conversation and will prepare Income Tax return. The Minimum additional Charges for this service (Assisted Filing) will be Rs. 1000 (since Rs. 500 is collected as an advance during booking an appointment with our expert). The additional amount payable by you for the premium service availed will be communicated to you by our experts during the live chat interactions as per your scheduled time.

- Once return is prepared, user will review and confirm if any further changes required or not.
- User will proceed for final payment of filing fee to confirm the return.
- User will get the ITR-V / Acknowledgment shortly after confirmation.
